The inclusion of judges in between assignments breaks partially the method of accounting the regular staff. However, between 217 positions of Judges for a judicial area, created in 1st January of 2015, only 47 of them have been temporarily filled. Moreover, 395 judges in between assignments have been attached like supplementary and substitutes. This data should be considered in evolution analysis, both in absolute number and on judges per 1.000 inhabitants.

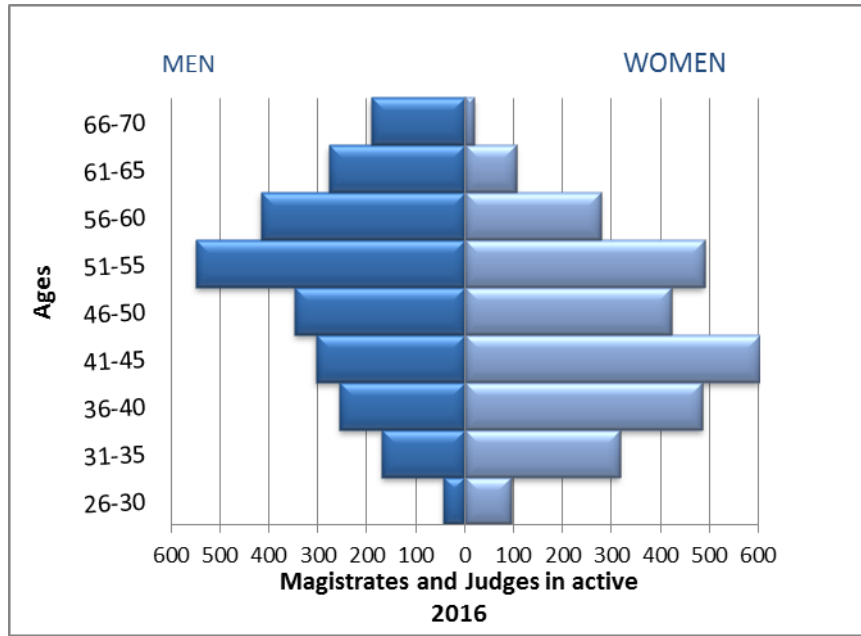

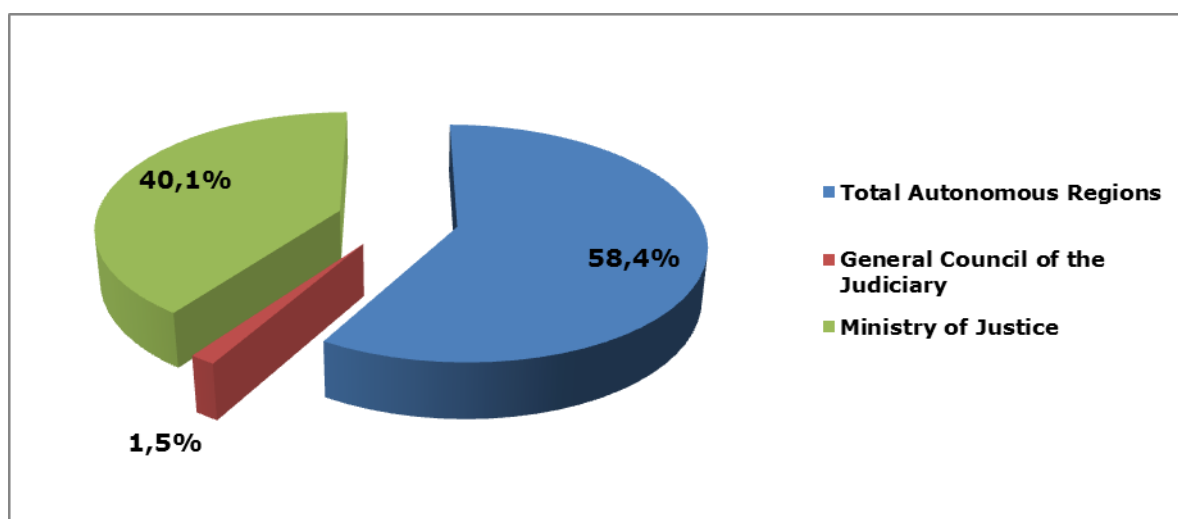

Rotation index (RI): Relationships between of number of investitures both of permanent positions and others, and the staff allocated for that professional status. This is a measurement of the stability of the staff.

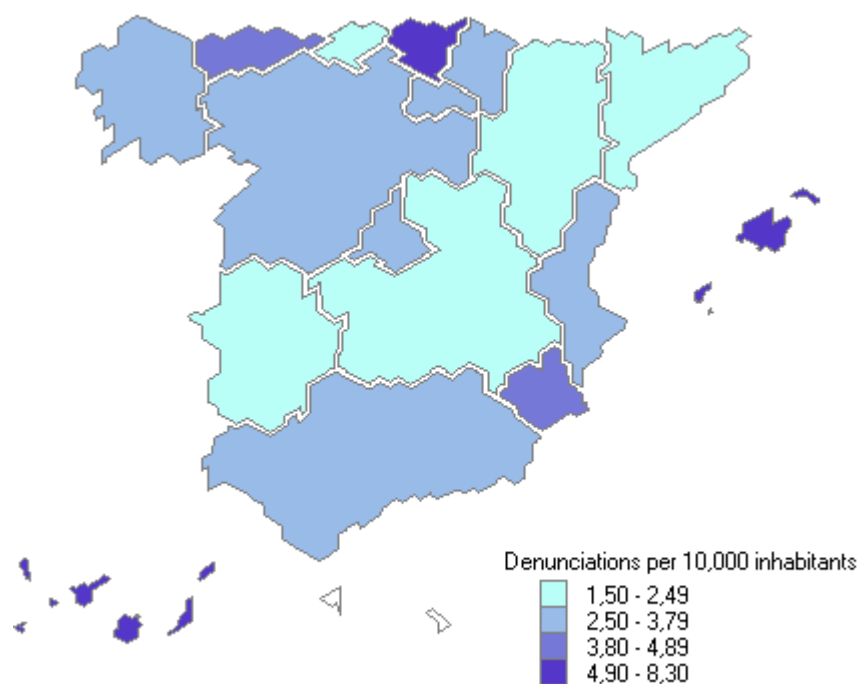

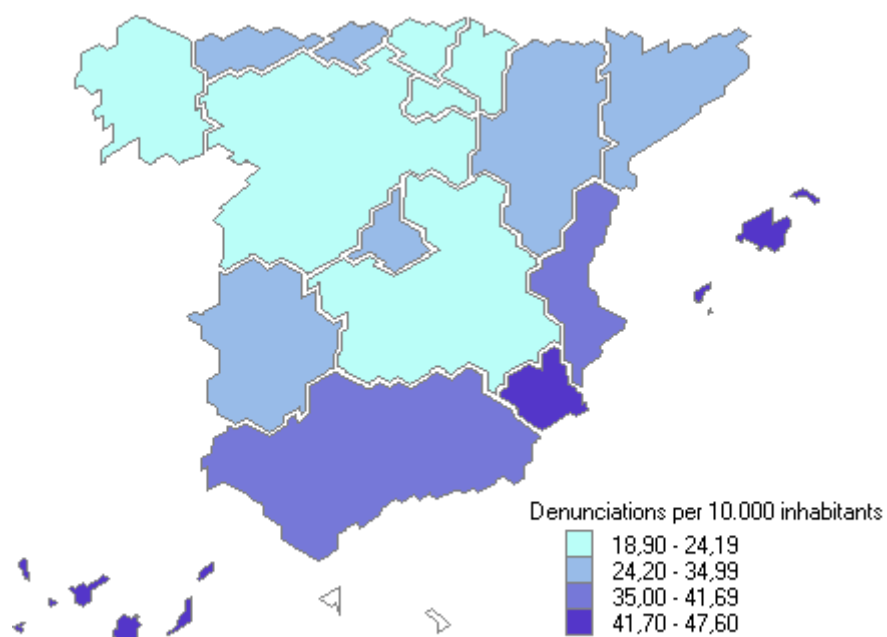

ESTIMATED LENGTH OF PROCEEDINGS

The average length of proceedings is another very important indicator of the Quality of the Justice. As the Judicial Statistics does not offer direct data from lengths, we present a set of evaluation produced by a mathematical model, according to the data from General Council of the Judiciary. Judicial Statistics: Incoming cases, resolved cases and pending proceedings at the beginning of every period of time. It offers an estimation of the average length of the cases ended in each period. **Length is stated in months.**

In the class with the most instances, *Speed and use of modern technologies in justice*, the following matters prompted the largest number of complaints:

- The right to a speedy processing concerning them and to be informed of the reasons for any delays (3.273).
- The right to be provided with suitably designed forms (175).
- Staff absences in judicial office (140)
- The right to be provided with a good organisation of judicial services (44).
