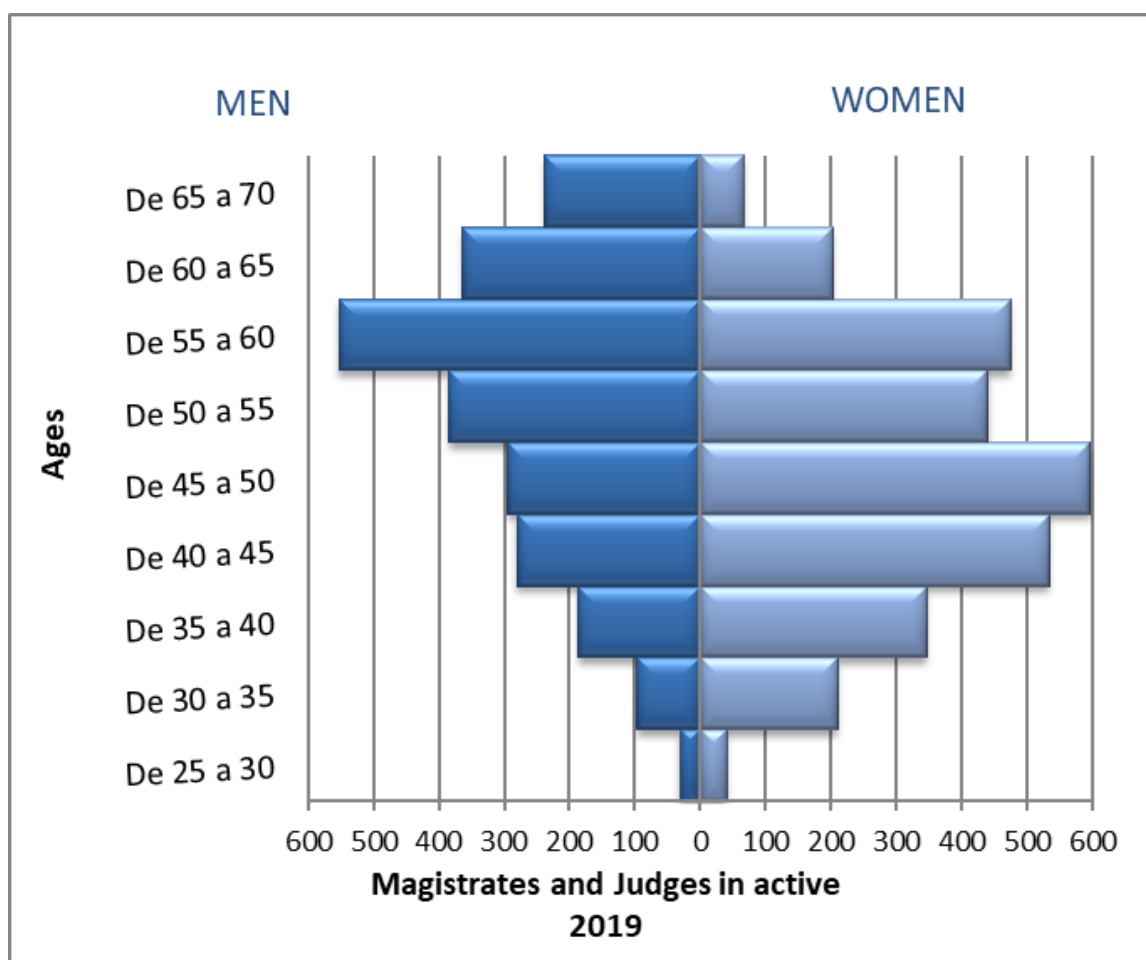

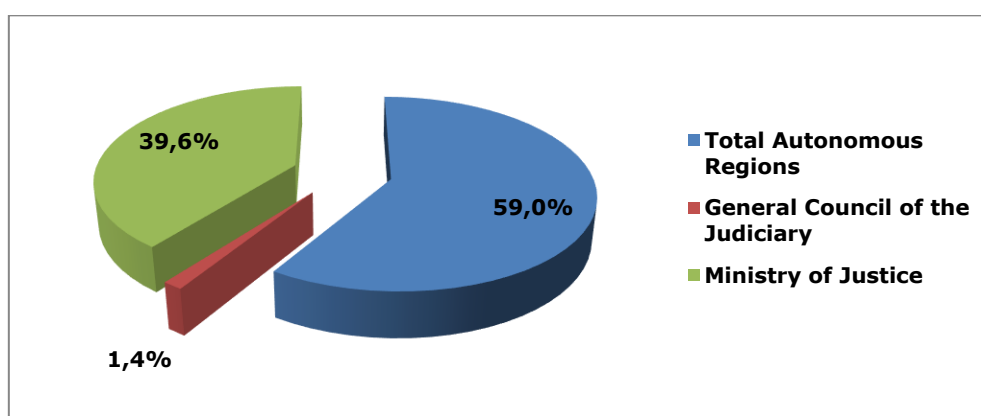

Rotation index (RI): Relationships between of number of investitures both of permanent positions and others, and the staff allocated for that professional status. This is a measurement of the stability of the staff.

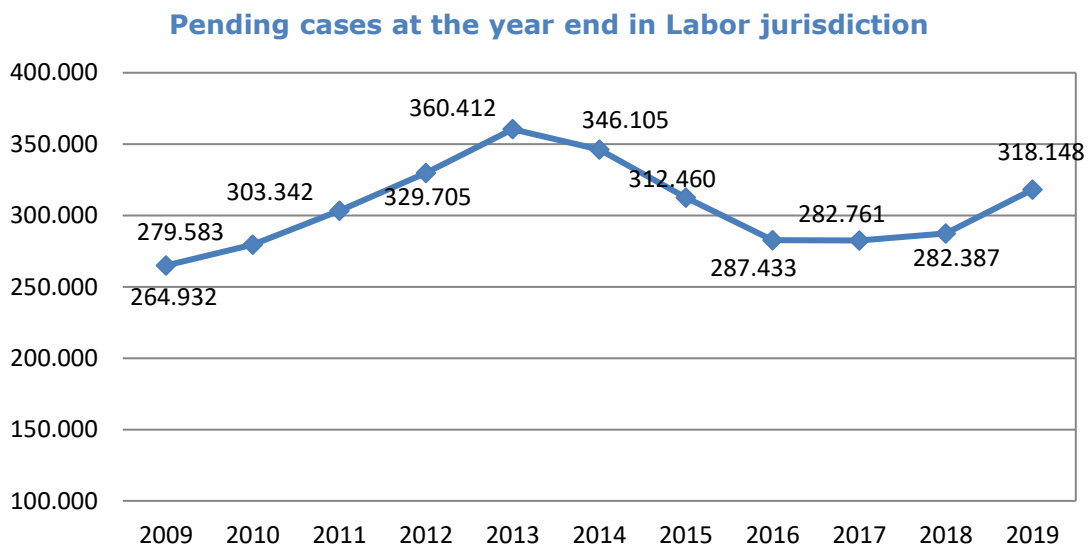
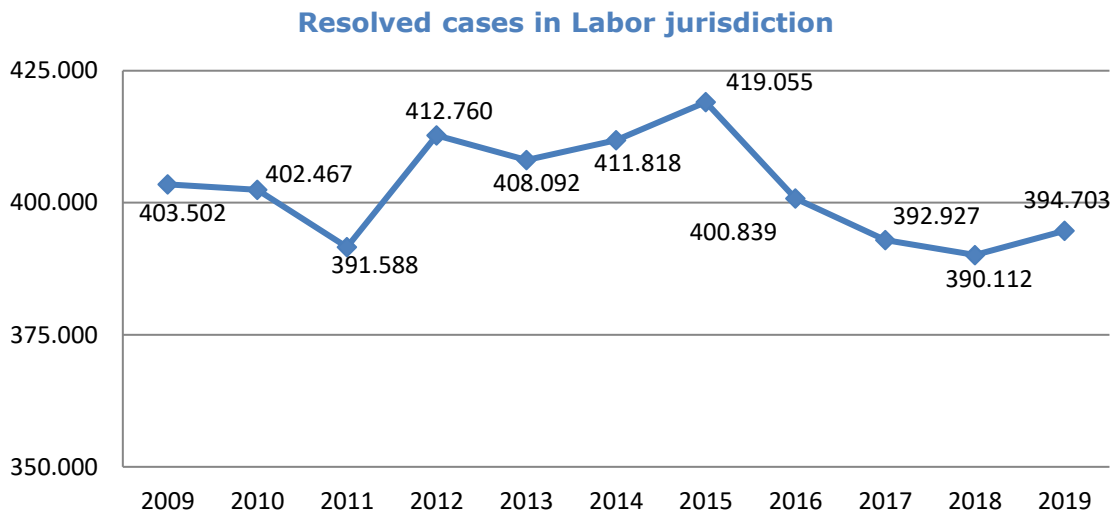
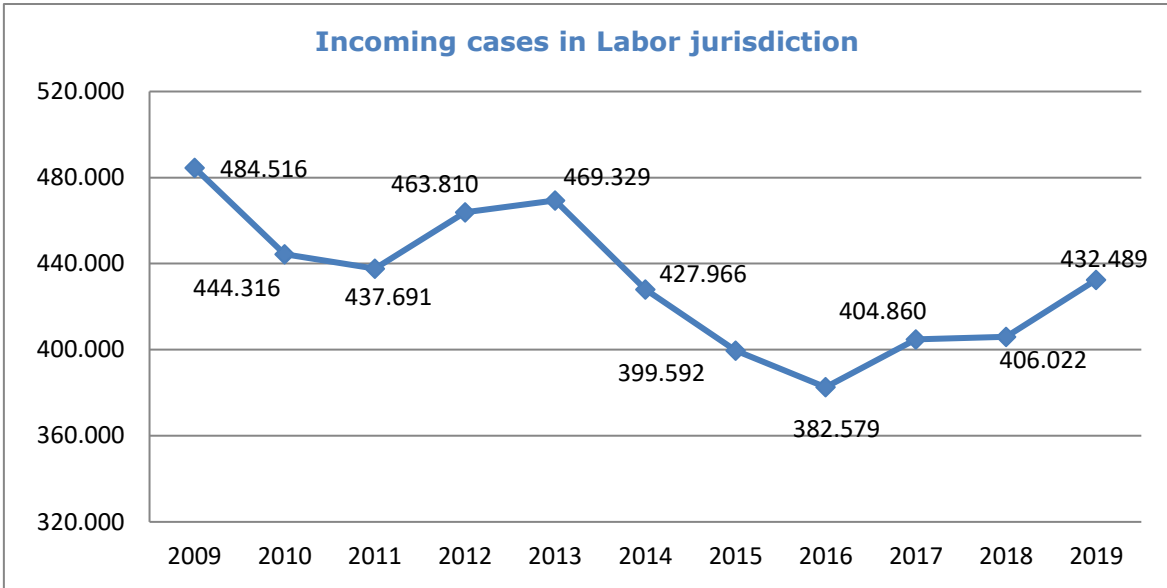




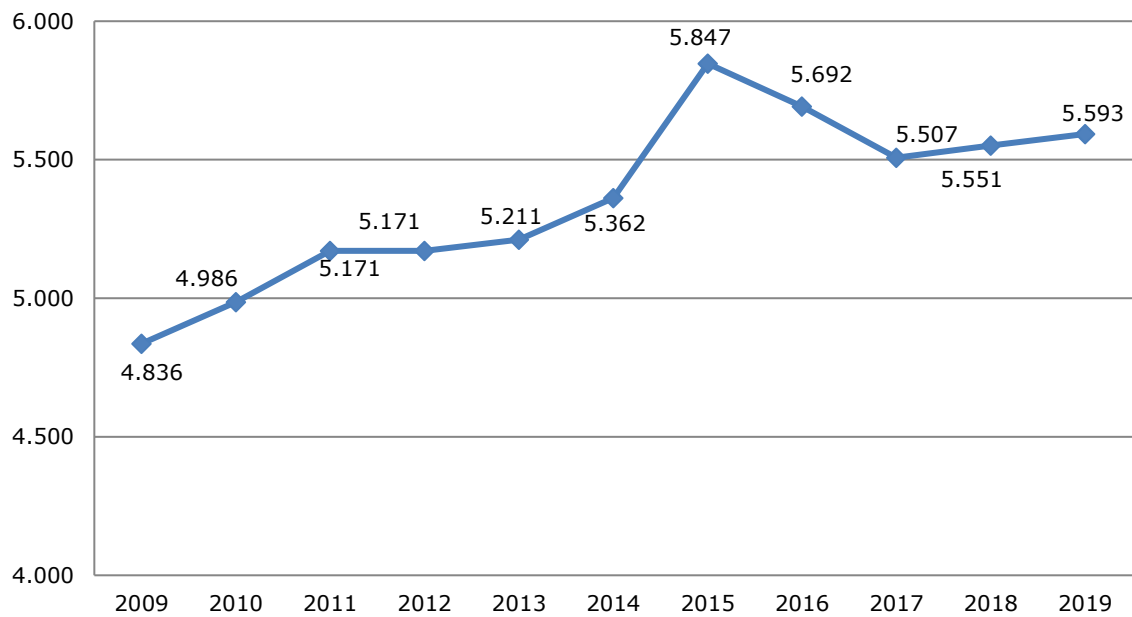




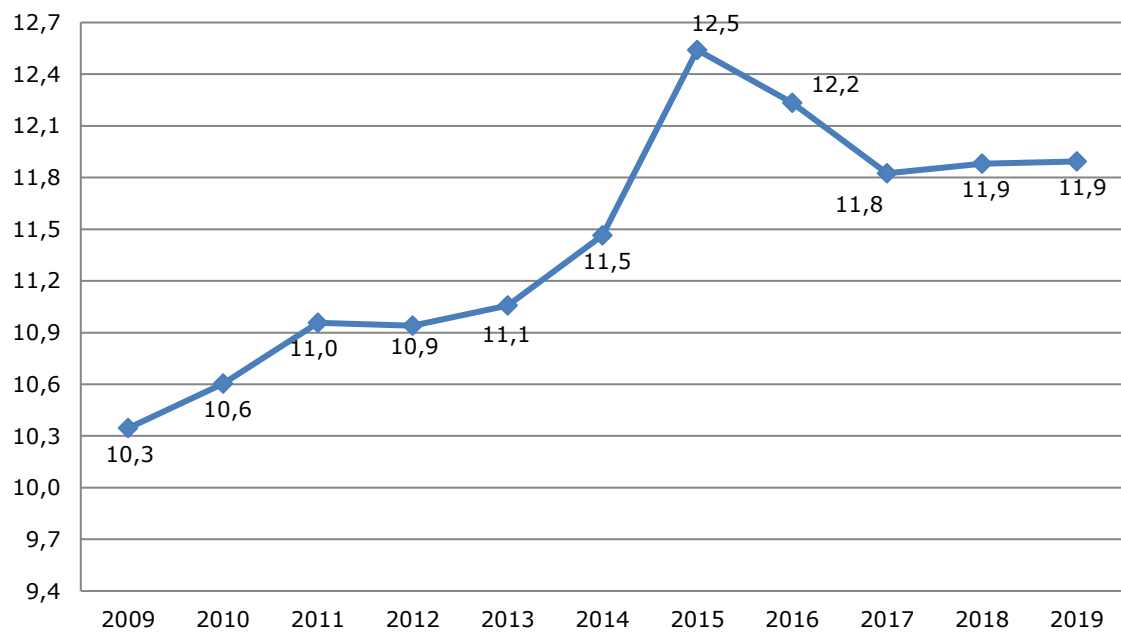




Staff of Judges and Magistrates sitting in Courts as 1ST at January

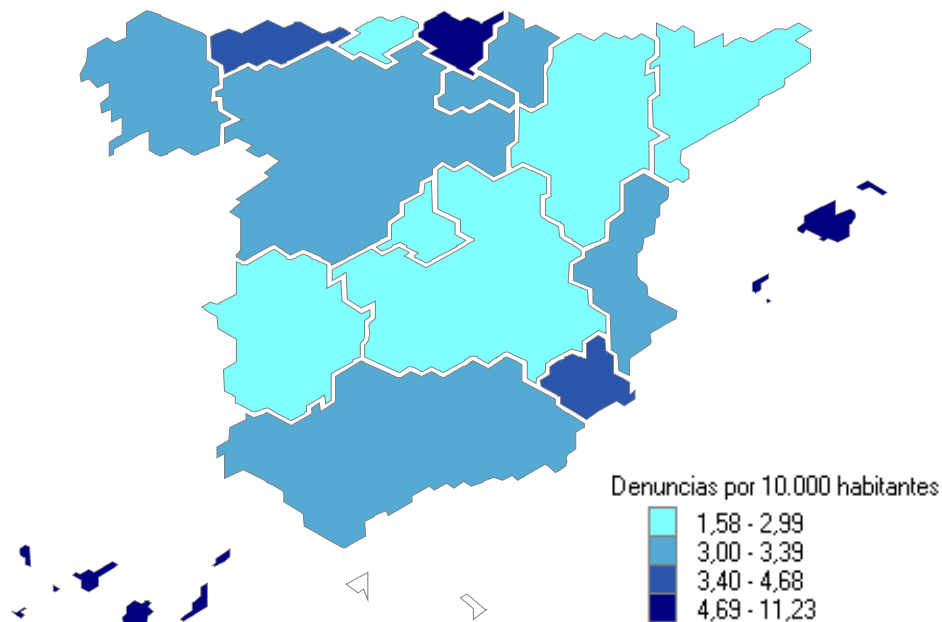

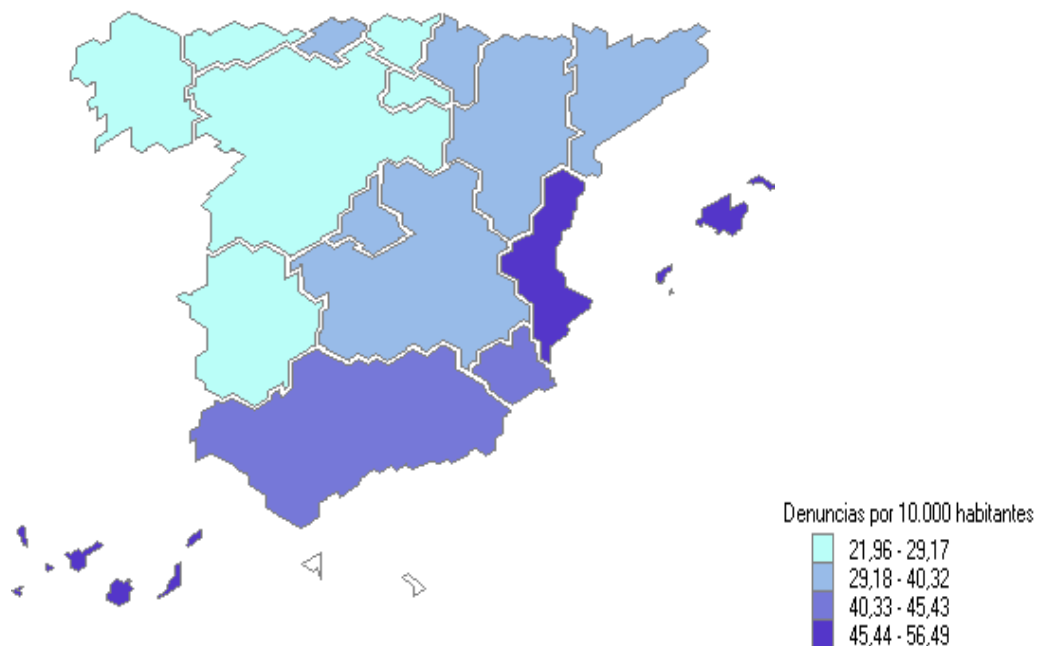

ESTIMATED LENGTH OF PROCEEDINGS

The average length of proceedings is another very important indicator of the Quality of the Justice. As the Judicial Statistics does not offer direct data from lengths, we present a set of evaluation produced by a mathematical model, according to the data from General Council of the Judiciary. Judicial Statistics: Incoming cases, resolved cases and pending proceedings at the beginning of every period of time. It offers an estimation of the average length of the cases ended in each period. **Length is stated in months**⁴⁵.
